


LOCATION & GENERAL INFORMATION

The Shanks property is located 1 mile south of Niota, IL on County Road 1120E (Niota, IL is directly across the Mississippi River from Fort Madison, IA). It is situated in the North Half of Section 14 of Appanoose Township, Hancock County.

TRACT 1 - 26 acres (subject to survey) consisting of beautiful, rolling, hardwood timber with some marketable trees. It also has a small pond. This property offers excellent deer and turkey hunting as well as some attractive, potential new home building sites with Dallas Rural Water available. County Blacktop 1120E borders the west side and 2770N borders the south side. Prospective buyers have permission to walk over and inspect this tract.

TRACT 2 - 2 acres (subject to survey), improved with a 3 bedroom home which is in need of some major repairs. The full basement includes a single car garage. It is serviced by Dallas Rural Water.
